# ARTICLES OF INCORPORATION

We the undersigned for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317 Minnesota Statutes, known as the Minnesota Nonprofit Corporation Act, do hereby associate ourselves together as a body corporate and adopt the following Articles of Incorporation:

#### ARTICLE I

The name and address of this corporation shall be Big Pine Lake Lakeshore Property Owners Association, Rural Route 2, Hazelton Township, Aitkin County, MN 56431.

#### ARTICLE II

The purpose of this corporation shall be the promotion and betterment of those persons interested in the ownership, care and use of the privilege of owning lakeshore property, and for a select group of persons owning land adjacent to Big Pine Lake who shall be eligible for Non-Voting memberships; the furtherance of good fellowship, the conservation of fishing resources; aid in the formulation and establishment of sound policies and practices designed to conserve, restore, protect and safely regulate the natural resources of Big Pine Lake and thereto, to work towards fish stocking, control of lake level, the encouragement of a just and fair equalization of the tax burden; to unite our efforts to solve mutual problems which include, but are not limited to algae litter, pollution, water level fish stocking and vandalism, to promote fellowship and extend acquaintances by means of social gatherings, educational meeting and lectures; to inculcate civic conscientiousness by means of active participation of constructive projects which will improve Big Pine Lake; to do all and everything necessary, suitable and proper for the accomplishment of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and do every other act or acts, thing or things, incidental or appurtenant to or growing out of, or connected with the aforesaid objects or purposes of or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

### ARTICLE III

This Corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

### ARTICLE IV

The period of duration of corporate existence of this corporation shall be perpetual. The affairs of the corporation shall be carried out by an elected and/or appointed Board of Directors, through Bylaws which were established for that purpose.
