    - i. Discovered that the MN-DNR must host the trainings for AIS inspections
    - ii. We need 5+ to set a training
    - iii. DNR requirement is to assure workers comp if any issues arise.
  - f. **MLR-Lake Steward:**
    - i. We did not purchase the MLR booklets as the county has similar ones for free.
    - ii. Charging \$25 for a smaller sign that will be lass clutter along shoreline
